DIRECTIONS FOR USE

One TROUGH BLOCK treats approximately 6750 litres of water. Eg. place one block for 30 sheep or 15 cattle in a nonmetallic or painted water trough. Replace block when slime starts to return . Usually lasts 5-8 weeks. Do not use in areas where copper toxicity is known to occur, or in bare metal troughs.

NOT TO BE USED FOR ANY PURPOSE OR IN ANY MANNER CONTRARY TO THIS LABEL UNLESS AUTHORISED BY APPROPRIATE LEGISLATION

CAUTION

If stock are suspected of having Lupinosis, remove blocks from troughs immediately.
